1. Opening

- a. Quorum present
 - i. Meeting called to order 5:00 p.m.
- b. Invocation led by Ray O'Brien.
- c. Public Comments
 - i. None
- d. Review and Consider Approval of Previous Meeting Minutes
 - i. Motion made to approve the October 16, 2024 regular session meeting minutes as read. Motion seconded. Four (4) votes in favor of approving minutes; zero (0) votes against. Motion passed; minutes approved as read.

2. Matters for Discussion and/or Action

- a. Vacation Buy-Back Policy
 - i. Kody presented the Board of Directors with a new employee vacation buy-back policy.
 - ii. Current policy allows employees to carry over twenty-four (24) hours of unused vacation to the next year, but stipulates employees will lose anything over twenty-four (24) hours of the unused benefit without any compensation.
 - iii. By law, once the benefit has been accrued, it cannot be taken away, the old policy has been the cause of deficiencies in our annual audit.
 - iv. New policy will pay employees for excess hours, up to 40 hours. The cost is cheaper to the hospital as we will not need to pay overtime or hire agency nurses to cover shifts and will also fix the deficiency with the annual audit.
 - v. Discussion held regarding vacation hours and the new policy.
 - vi. Motion made to approve the employee vacation buy-back policy as presented. Motion seconded. Four (4) votes in favor, zero (0) votes against. Motion passed; Vacation Buy-Back Policy approved as presented.

- b. EMS Contract with Frontier Ambulance Corp.
 - i. John Schmidt abstains from discussion and voting on this matter due to his involvement with Frontier Ambulance Corp.
 - ii. Discussion held regarding the EMS contract with Frontier Ambulance Corp.
 - iii. Motion made to accept the EMS contract with Frontier Ambulance Corp. as presented; motion seconded. Three (3) votes in favor, one (1) member abstains, zero (0) votes against. Motion passed. The EMS contract with Frontier Ambulance Corp. was accepted as presented. Contract was signed by Betty Lyon after approval.
- c. Canvass November 5, 2024 Board of Directors election results for precincts 2 and 4
 - i. Board of Directors members presented with results of the elections.
 - i. Betty Lyon was elected to Precinct 2 over Scotty Simpson
 - ii. Matt Patterson was elected to Precinct 4 over Richard Houston.
 - a. Noted Mr. Houston had wanted to withdrawal his name from the election, however the ballets had already been printed.
 - ii. Motion made to approve the canvass of the November 5, 2024 Board of Directors elections results for precincts 2 and 4. Motion seconded. Four (4) votes in favor, zero (0) against. Motion passed; Canvass results of the November 5, 2024 Board of Directors election results for precincts 2 and 4 approved.
 - iii. New terms begin January 1, 2025 and elected officials will need to take an oath of office.
